



## **High-Performance Program Special Consideration Request Form**

---

Per Hockey NL's High Performance Program Policy Manual, there are three situations in which a player can apply for special consideration to participate in the next step phase of the High-Performance Program. Please note if this form is approved for Injury/Illness or Compassionate Reasons, you will only be **considered** for the next phase. If this form is approved through the Out of Province Evaluation Rubric players will be given an exemption to attend the next phase. The decision on whether a player qualifies for consideration through injury/illness, compassion, or being out of province rests with the Hockey NL Chair of Hockey Development, Chair of Female Hockey and the Manager of Development & High-Performance.

All three situations in where a player can look for Special Consideration are listed below.

**Injury / Illness** - Players may be excused from certain aspects of the Program due to injury. Injured participants must provide, to the Manager of Development & High-Performance prior to the first session of the phase to be attend. Written confirmation from their physician detailing the injury and confirmation that the injury was serious enough to prevent them from participation in the program at that time because of the injury will be required.

**Compassion** – Players may be excused from certain aspects of the Program for compassionate reasons. Participants who wish to make application for this exemption must do so by filling out this form and sending it to the Manager of Development & High Performance prior to the first session of the phase to be attended.

**Out of Province**- Players may be excused from Spring HPP Camp or Phase #1 of the Male U16 High-Performance Program due to attending a school out of province while camp occurs. Participants who wish to make an application for this must complete the High-Performance Program's Special Consideration form and send it to the Manager of Development & High-Performance 21 days prior to the first session of the phase to be attended. Upon receipt of such application, the Chair of Hockey Development, Chair of Female Hockey and Manager of Development & High-Performance will use the HPP Out of Province Evaluation Rubric to render a decision. Out of Province exemptions that are approved will guarantee an invite to the next phase of the program if the guidelines of the approved exemption aren't violated.
