Nominations received after that date will not be considered, with the only exception being if there are no candidates

nominated, we will allow nominations from the floor during the Annual Meeting.

The Nominating Committee will be releasing the final slate of candidates along with the respective resume and information to the membership on or before the notice of the Annual Meeting of the Members.

The election for the positions will take place during Hockey NL's Annual Meeting on **June 13, 2026**, in Gander.

There will be no acclamations and members will have the ability to abstain in elections as per Hockey NL By-Law XI.
